**THE EAST AFRICAN COMMUNITY  
APPROPRIATION ACT, 2017**

**An Act to make appropriation out of the East African Community Budget to the service of the financial year ending 30th June, 2018.**

*Date of assent:* 16th November, 2019.

*Date of commencement:* 1st July, 2017.

ENACTED by the East African Community and assented to by the Heads of State.

1. This Act may be cited as the East African Community Appropriation Act, 2017 and shall come into force on the 1st day of July, 2017.

2. The Secretary General may issue out of the budget of the East African Community and apply towards the supply granted to the Community for the services of the year ending on the 30th June, 2018, the sum of United States Dollars One Hundred and Ten Million, One Hundred Thirty Thousand, One Hundred Eighty Three.

Appropriation of sums granted

**3.** The sums granted by this Act shall be appropriated for the services and purposes specified in the Schedule to this Act.

Payment for services in previous financial year.

**4.** Any part of the sums granted by section 2 which has been, or is issued from the budget of the East African Community before the 30th June, 2018 shall be available until a date to be determined by the Council of Ministers, not being later than the 31st day of December, 2018 for making payments which become due during the year ending on the 30th June, 2018.
